

## **NOTICE OF 2020 PRESIDENTIAL GENERAL ELECTION SCOTLAND COUNTY, NORTH CAROLINA**

A presidential general election will be held on Tuesday, November 3, 2020 in Scotland County to vote in the following contests: US Presidential Preference, US Senate, US House of Representatives District 9, NC Governor, NC Lieutenant Governor, NC Attorney General, NC Auditor, NC Commissioner of Agriculture, NC Commissioner of Insurance, NC Commissioner of Labor, NC Secretary of State, NC Superintendent of Public Instruction, NC Treasurer, NC Supreme Court Chief Justice, NC Supreme Court Associate Justices, NC Court of Appeals Judges, NC State Senate District 25, NC House of Representatives District 48, NC Superior Court Judges District 16A, NC District Court Judges District 16A, Board of Commissioners, Board of Education and Soil and Water Conservation Supervisor.

Voters will not be required to show photo ID for elections held in 2020. Federal and state courts have temporarily blocked North Carolina's voter photo ID requirement from taking effect until further order of the court.

Polls will be open from 6:30 a.m. to 7:30 p.m. on the day of the election, Tuesday, November 3. One-stop early voting will be held at the Board of Elections conference room located at the County Annex Building at 231 East Cronly Street, Laurinburg, NC. One-stop early voting will be open from Thursday, October 15 until 3:00 p.m. on Saturday, October 31. The hours are 8:00 am to 7:30 pm on each weekday, 8:00 am to 1:00 pm on October 17 and 18, 8:00 am to 6:00 pm on October 24 and 8:00 am to 3:00 pm on October 31. Canvass will be held in the Scotland County Board of Elections conference room at 11:00 a.m. on Friday, November 13.

Absentee voting by mail is available. Requests for an absentee ballot must be made on an absentee request form (available on the State Board of Elections website, the county website and at the county board of elections office), and must be received in the Scotland County Board of Elections office or the one-stop early voting site by 5:00 p.m. on Tuesday, October 27. Completed request forms may only be returned in-person to the Scotland County Board of Elections by the voter, the voter's near relative or verifiable legal guardian, or by a Multipartisan Assistance Team, or delivered by the U.S. Postal Service or designated delivery service (DHL, FedEx, or UPS). Absentee voting requires the voter to complete an application on the return envelope that must be witnessed by one qualified person. Completed absentee ballots must be returned to the Scotland County Board of Elections by 5:00 p.m. on Election Day (ballots received by mail after this time will be timely if received within three business days and postmarked by Election Day November 3). Voters may receive assistance voting a mail-in absentee ballot from a near relative or verifiable legal guardian, or qualified person of their choice. If the voter lives at a facility such as a nursing home, and the voter's near relative or legal guardian is not available, the voter or the facility can arrange to have the county board of elections schedule a visit by a Multipartisan Assistance Team to provide assistance and serve as a witness.

All persons who are registered to vote with the Scotland County Board of Elections may vote in this election. Persons who are not already registered to vote in the county must register by Friday, October 9 to be eligible to vote in this election. Voters who are not registered in the county by that deadline may register and vote during one stop early voting only, and will be required to provide documentation of their identity and residence. Voters who fail to timely make a change in name or address in the county must update the information when presenting to vote, and may be required to vote a provisional ballot.

Voters voting in person are entitled to assistance by an election official, or, if assistance is needed due to disability or illiteracy, by a qualified person of their choice. Voting sites are accessible to all voters. Curbside voting is available for voters who are not able to enter voting sites.
